-Foreign Travel (NLT 30 days prior to travel)
-Change in marital status
-Legal name change

MEMORANDUM FOR RECORD

SUBJECT: Social Media, Presidential Support Duty

1. Members selected for Presidential Support Duty (PSD) may not post (or upload) information, pictures, images, video, or text on the internet (or other publicly accessible media) that imply or explicitly reveal:

-Their assignment to White House Communications Agency, White House Military Office or any of its operational units

-Presidential support duties and activities at home station, while on temporary duty/travel, or while awaiting Permanent Change of Station to the White House Communications Agency or it's operational units.

2. Members selected for Presidential Support Duty are personally responsible for all content they (or others on their behalf) post (or upload) on social media. Social media includes any form of electronic communication (such as websites and smart phone applications for social networking and microblogging) through which users create online communities to share information, ideas, personal messages, and other content (such as videos).

3. I have read and understand that I am required to adhere to the social media standards outlined above. I further understand that my failure to adhere to these standards may affect my suitability for Presidential Support Duty and security clearance.
